**EVERYDAY**  
**Turkey Starter Crumbles**  
**MEDICATED**  
**Type C**

For the prevention of coccidiosis caused by Eimeria adenoeides, E. melagrimitis and E. gallopavonis.

**DIRECTIONS FOR USE:** Feed continuously to growing turkeys as the sole ration from 1 day of age to 8 weeks of age. Limitations for use: The optimum level depends on the severity of coccidiosis exposure.

**CAUTION:** Do not allow horses, other equines, mature turkeys, or guinea fowl access to feed containing monensin. Ingestion of monensin by horses, mature turkeys and guinea fowl has been fatal. Some strains of turkey coccidia may be monensin tolerant or resistant. Monensin may interfere with development of immunity to turkey coccidiosis. Coccidiosis risk in young turkeys not receiving anti-coccidials outweighs the risk of infrequent coccidiosis outbreaks that may occur following withdrawal.

**ACTIVE DRUG INGREDIENT:** MONENSIN 90g/ton
